The practice of medicine has changed dramatically in the last 25 years or so. There have been many new conditions discovered, many new treatments developed, and many new types of medical devices have been placed into service. The ICD-9 code set was not designed to capture all of this progress, and as such, has become bogged down with many types of modifications to attempt to capture information. The ICD-10 code set is much better at describing the current practice of medicine, and has the flexibility to adapt as medicine changes.

One of the most important concerns in the transition from ICD-9-CM to ICD-10-CM codes is that there is no simple mapping or translation from the former to the latter. There are some one-to-one correspondences, but often there are one-to-many, many-to-one, manyto-many, or no correspondence at all.

Even people with insurance coverage have frequently been denied care because until recently, mental health conditions have been covered differently than medical conditions.

Merriam-Webster defines parity as "the quality or state of being equal of equivalent." This is a simple definition, but the meaning becomes muddy when it comes to deciphering the Mental Health Parity and Addiction Law (MPHAEA).

The Parity Law, which was approved in 2008 and became effective in 2010, applies to insurance providers and group health plans that provide coverage for both medical and surgical benefits and mental health/addiction. More Information

#### The Supreme Court has **Decided in Favor of the American People**

Hallelujah, for the second time! As a not entirely unexpected outcome, the Supreme Court this week ruled in King v. Burwell. This 6-to-3 decision upholds the authority of the US Department of Health and Human Services to pay insurance premium subsidies under the Affordable Care Act (ACA) to persons who seek insurance through the federal health insurance marketplace.

This decision has very broad implications. The Department operates the health insurance marketplaces for 34 states, and 85 percent of those insured actually receive premium subsidies. Families USA estimated recently that up to 6.4 million persons could lose their health insurance if the Supreme Court had struck down this provision.
