Controversial ADHD prescription rule scrapped from Georgia bill	Commercial weight-loss drug could help treat opioid addiction
<p>A provision of a Georgia Senate bill that would have required adults and children on ADHD medications to get new prescriptions every five days has been scrapped.</p> <p>The proposed changes were presented before the Georgia Senate's Health and Human Services Committee on Thursday afternoon.</p> <p>State Sen. Renee Unterman, the committee's chairwoman, had created a bill aimed at curbing the abuse of prescription opioids in Georgia. But controversy erupted as word spread of the provision that would have imposed restrictions on attention deficit hyperactivity disorder medications as well as other prescriptions.</p>	<p>Scientists are working to come up with new therapies to curb America's opioid epidemic and aid hospitals, doctors and public health officials in this fight. Now one team reports that the commercial weight-loss drug lorcaserin, when given to rats who had been self-administering oxycodone, appeared to reduce their use of and craving for the opioid.</p> <p>The U.S. Centers for Disease Control and Prevention estimates that the number of deaths in the U.S. from prescription opioid overdoses has quadrupled since 1999 to the present day.</p>

### A 10-Minute Meditation to Help You Solve Conflicts at Work

There are few things at work as stressful as feeling that you can't communicate with someone who has an impact on how well you do your job and on the quality of your experience at work. How many times have you thought carefully about something you want to communicate to your boss, a colleague, or subordinate, only to find yourself leaving the conversation feeling angry or frustrated by how it went?

Karen (not her real name), a program officer for a nonprofit organization, had an experience like this when she first tried to convince her boss, Maria, to let her work from home three afternoons per week. She had thought carefully about how to make the most persuasive argument. She was prepared with a rationale that addressed her own needs as well as her employer's, details of how she would manage communication while physically absent, and buy-in from colleagues.

### Anthem Easing Access to MAT and Counseling Services

Health insurer Anthem recognizes the combination of behavioral health counseling and drug therapy as a best practice for substance use disorder treatment. There's just one problem: The insurer's internal research found that fewer than 1 in 5 members receiving medication-assisted treatment (MAT) have also been receiving counseling.

To that end, Anthem has announced changes that will enhance reimbursement to providers of MAT services and double the number of members who receive behavioral health counseling as part of their drug therapy for opioid addiction.

"It says it all in that title: It's medication-assisted therapy," Sherry Dubester, MD, Anthem's vice president of behavioral health and clinical programs, tells *Behavioral Healthcare Executive*. "We want to make sure we do what we can to increase access to both to the medication and to the supporting services."

Between 16% and 19% of Anthem plan members receiving buprenorphine products to treat opioid use disorder were also receiving in-person counseling, according to Anthem research. The plan changes that will aim to double that figure were first tested with three Anthem affiliated plans in the Northeast in 2016 and are slated to be extended to all Anthem health plans by early 2018.


