Gov. Stitt pushes back on mental health cut claims, defends shift in vendor contracts

Oklahoma Gov. Kevin Stitt addressed concerns about alleged mental health funding cuts, clarifying that the state's \$800 million mental health budget remains unchanged. He said recent changes aim to redirect funds toward more efficient service providers, not reduce services. Stitt criticized some vendors for high costs and lack of accountability, stating that altered contracts mainly involve discretionary bonuses, not core funding. He accused certain nonprofits of fueling public concern to protect their funding and urged the public to understand the difference between vendor changes and actual budget cuts, emphasizing the goal is to better serve more Oklahomans.

\$4M awarded to fight opioid crisis in northwest Ohio

Millions in opioid settlement funds are being distributed across northwest Ohio to support addiction recovery, with \$4.1 million awarded in the first round of grants. Overseen by the OneOhio Recovery Foundation, the funds come from settlements with ten pharmaceutical companies. Harbor received the largest grant at \$529,542 to expand prevention efforts for the LGBTQ+ community, while Lucas County Children Services and the Zepf Center received over \$463,000 and \$400,000 respectively for family recovery programs and peer support staff. OneOhio's director said more funding cycles are planned as additional settlements are finalized.
