OKLAHOMA ATTORNEY GENERAL SIGNS NON-ENFORCEMENT AGREEMENT ON HEALTH CARE BAN FOR TRANS YOUTH

Governor Kevin Stitt signed SB 613 into law today banning all irreversible gender transition surgeries and hormone therapies for children under the age of 18. [Bill SB 613](#) bans all forms of gender-affirming medical treatment for transgender adolescents and threatens providers who violate the law with a felony conviction and discipline from their professional licensing boards.
